#### **Explanation of Significant Variances**

#### Year ended 31st March 2021.

#### <u>Income</u>

The council received a grant of £500 from the Cumbria Community Foundation to replace the fittings in the Ladies' toilets at the Village Hall. This was received in the year ended 31<sup>st</sup> March 2021 but will be spent in the following financial year.

A grant of £100 made in 2018 to the Cumbria Children's Dyslexic Association was returned as the charity had been unable to spend it.

#### **Expenditure**

Overall expenditure was lower than anticipated due to Covid-19 restrictions.

The Clerk participated in online training so that council meetings could be held via Zoom. This incurred a one-off payment of £45.

A defibrillator was purchased at a cost of £2,641.20, utilising grants awarded in the year ended 31<sup>st</sup> March 2020.

#### **Fixed Assets**

These have increased by £2641 to £8540 to include the defibrillator purchased in 2020/21
