10/18 Approval of Minutes

- iv) A new bookshelf had been donated by Forth Engineering Clerk to send a letter of thanks to Mr Mark Telford, Managing Director. Thanks were expressed to Mrs Carol Elliott for putting all the books onto the new shelving unit.
